Department of "Economics, finance and business", implementing an educational program bachelor 5B050800 - "Accounting and Audit", is a subdivision of the Faculty of "Law, Business and Information Technologies" University "Bolashak".

The department carries out scientific-practical and scientific-pedagogical and scientific-methodological research. At the moment, preparing students for the OP for the specialty 5B050800 - "Accounting and audit" on the basis of the state license №0137438, AB series, issued by the Committee for Control of Education and Science of MES RK from 03.02.2010 year. Period of validity of the license with out restriction.

The objectives of the educational programs meet the mission, strategic plan, aims and objectives of the University and satisfy the needs of students to obtain relevant qualifications and competencies.

The aim of the educational program 5B050800 - "Accounting and audit" istotrainhighly qualified professionals within-depthscientific training, are able to carryout professional active tie sat a high level.

The objectives of the educational program are: training of highly qualified personnel; the formation of fundamental knowledge and skills needed in professional work, mastery of advanced knowledge in the field of accounting and auditing, adaptation to rapidly growing information technology, orientation graduates fundamental knowledge on the intersection of science, guaranteeing their professional mobility in real developing world, providing Kyzylorda region needs and the southern region of the Republic of Kazakhstan in the competitive frames.

Requirements for the competence of the educational program 5B050800-"Accounting and Audit" Bachelor meet state educational standards (SES RK № 6.08.009-2008)

Training BA in 5B050800- "Accounting and audit" is based on the national model of education, results-oriented, and involves training of competent and competitive specialist in the field of accounting and auditing, which owns a multicultural and communicative, capable of professionally and creatively solve on modern scientific and practical the level of economically significant challenges in the industrial, commercial and other fields.

The contents of mandatory educational component of the program and meet the requirements of SES model curriculum. EP developed in the language of instruction in accordance with the JI, standard curriculum, working curriculum and the catalog of elective disciplines graduating department, held a discussion at the department, approved at the Educational advisory board of the Faculty and the University, on the basis of which prepare individual education plans, work training programs . In accordance with the SES RK specialty all subjects of the curriculum are grouped into cycles of general education disciplines (GED), basic disciplines (BD) and profile disciplines(PD). The educational program of the following distribution of credits: Total - 129 credits: GED - 33, BD - 64, PD - 32.Organization of practical training for EP 5B050800- "Accounting and audit" are companies and LLC, located in the region

and the cities which have signed the agreement (JSC Kaspi bank Kyzylorda, LLC "Kalampyr", LLC "Sarykaska-Engineering "Ltd, and Olzhas K., and others.)

Students enrolled in the EP are its main consumers. Accounting for their educational interests and needs are fundamental in ensuring the educational process. Training EP conducted in the state and Russian languages. On the basis of the State program of education development in the Republic of Kazakhstan for 2011 - 2020 years. (Presidential Decree № 1118 of 07.12.2010.) In the "Bolashak" university drafted Strategic Development Plan 2014-2019. This plan envisages the introduction of trilingual education in educational groups in some specialties, and issued a corresponding order to the university (number 80B from 27.11.2015.) According to this order in the group of F-14, the AA-14 from the beginning of the 2016-2017 school year, training some subjects conducted in Kazakh, Russian, and the second semester English.

Teaching staff at EP 5B050800- "Accounting and audit" has a full knowledge and understanding of the specifics of the subject taught, the necessary skills and experience to effectively transfer knowledge to students as part of the learning process and is characterized by objectivity, adherence to principles in the assessment of its activities, the activities of colleagues, leadership any level students.

The total number of TPS, leading classes in general education, basic and majors for specialties 5B050800 - "Accounting and Audit" -36. Of these, full-time teachers - 28, accounting for 77.8% of the total number of PTS. Among them, 14 with advanced degrees that the proportion of full-time faculty with academic degrees and titles is 50.0%. Average age - 44 years.
